As controls get tighter and tighter, we are obliged to adhere to the terms of service we agreed to when creating content for our channel. As we have been receiving many thought-provoking and sensitive questions from our community viewers, we are often limited by what and how much we can say or expand on a topic. Each time we come up against this barrier, we feel disappointed that we cannot go into the depth or detail we feel would benefit and give a more specific answer to a question. There have also been many topics we would like to discuss but are limited on what we can "say" on a public platform. While we are careful to follow the guidelines and will continue to do so for our YouTube channel, there have been times that we want to talk about things which are considered too controversial. For this reason, we will only be sharing these types of articles and videos on our Patreon page. We will still continue to create videos for YouTube when it is appropriate, but in order to continue to provide expansion, not only for ourselves, but hopefully for those who are drawn to support our work, we find it necessary to start putting some things behind closed doors, so to speak.

If you have submitted a question to us (and we have saved everyone) that we want to expand in more detail and you are not a Patron, we will send you that expanded answer, privately.

We realize that this takes away the convenience of being able to view all our research on YouTube, but we asked a question earlier in the expanding version of this article which was, "What have we done and what have we allowed ourselves to agree to?" That wasn't a rhetorical question. The answer to this is the same as it has always been; we have been lured into the trap by convenience. This is always how they get us to agree, eventually. Remember, they know humans VERY well and they know we love our conveniences. In order to not agree with this system, we MUST be willing to let go of convenience. We cannot encourage those
